DESCRIPTION

BULLDOG Q.D. Primer is a rapid drying special heavy bodied asphalt material which will dry to touch 3-4 hours and will cure in 24 hours (depending upon thickness of film and outside temperature). MEETS SPECIFICATION: ASTM D 41, Type II

USES

Use BULLDOG Q.D. Primer for priming concrete, asphalt and metal surfaces before the application of other BULLDOG Dampproofing and Waterproofing compounds and systems. Use as a quick dry primer to create a better bond between the surface applied to and compatible materials. THIS PRODUCT IS FOR EXTERIOR USE ONLY.

METHODS AND RATE OF APPLICATION

Apply BULLDOG Q.D. Primer to clean, dry surface by brush, spray, or squeegee at rate of 100 square feet per gallon (.4 liters per M²). Rate of application may vary due to porosity of substrate. DO NOT THIN. COVER AIR INTAKES BEFORE APPLYING AND WHILE CURING. EMPTY CONTENTS BEFORE DISPOSING OF PAIL AND SPRAY CAN.
